

Statement of Publication Ethics:

Western Australian Law Teachers' Review

The *Western Australian Law Teachers' Review* (WALTR) is committed to upholding the highest standards of integrity, transparency, and professionalism in scholarly publishing. This Statement of Publication Ethics sets out the responsibilities of authors, editors, reviewers, and the journal in ensuring these standards are met.

Authorship and Responsibility

- Authorship must reflect substantial contributions to the conception, design, research, drafting, and/or revision of the work.
- All listed authors must approve the final version of the manuscript and agree to its submission. The corresponding author, by submitting their manuscript, warrant that all other listed authors approve the manuscript and its submission.
- Contributors who do not meet authorship criteria should be acknowledged.
- Authors are solely responsible for the accuracy and integrity of their work.

Originality and Plagiarism

- Submissions must be original works that have not been previously published or submitted elsewhere.
- Authors must properly attribute and reference all sources, including direct quotations, paraphrased material, data, and ideas of others.
- Plagiarism in any form is strictly prohibited.

Use of Generative AI and Automated Tools

- Authors may use generative artificial intelligence (GenAI) tools (such as ChatGPT, Claude, or similar) to assist with drafting, language refinement, or idea development. However:
 - GenAI tools cannot be listed as authors.
 - Authors remain fully responsible for verifying the accuracy, originality, and integrity of any content produced or assisted by GenAI.
 - Authors must exercise independent critical judgment, fact-checking, and ethical reasoning, in line with current judicial guidance which treats GenAI as an assistive tool, not a replacement for human authorship or accountability.

Peer Review Process

- WALTR uses a double-anonymised peer review process.
- Reviewers are expected to provide objective, constructive, and confidential assessments of submitted work.
- Reviewers must declare any conflicts of interest and decline to review where such conflicts exist.
- Reviewers must not use or disclose any information from the manuscripts they review.

Editorial Integrity and Decision-Making

- Editorial decisions will be made based on scholarly merit, relevance to WALTR's scope, and contribution to the discipline.
- Editors must act fairly, objectively, and without bias.
- Editors must disclose any conflicts of interest and recuse themselves from handling manuscripts where such conflicts exist.
- If an Editor submits any manuscript to WALTR, the entire review process is managed by another editor, with the author having no involvement in the process.

Conflicts of Interest

- Authors, reviewers, and editors must disclose any financial, institutional, personal, or other relationships that could influence (or be perceived to influence) the integrity of the work or the publication process.

Data Transparency and Research Ethics

- Authors must ensure that data, materials, and methods are presented transparently and, where possible, made available for replication or further research.
- Where research involves human participants or sensitive data, authors must confirm appropriate ethical approvals and compliance with relevant legal and ethical standards.

Corrections, Retractions, and Complaints

- WALTR will correct or retract published articles where significant errors, ethical breaches, or misconduct are identified.
- Complaints regarding ethical breaches will be handled confidentially, promptly, and in line with COPE (Committee on Publication Ethics) guidelines.

AI-Generated Images and Media

- The use of AI-generated images, diagrams, or graphics must be declared.
- Authors remain responsible for ensuring that such materials do not infringe copyright, are accurate representations of concepts, and meet WALTR's scholarly standards.

Submission agreement

- By submitting a manuscript to WALTR, the authors acknowledge, warrant, and agree to the terms set out at Annexure A.

Annexure A:

Submission agreement terms

- 1.** *The manuscript you submit is your own work created solely by you and no part of the manuscript violates (or will violate, if published) any copyright.*
- 2.** *If you refer to material not created solely by you, such material is properly attributed to its respective authors.*
- 3.** *If your manuscript relates to any research involving humans, you have obtained any necessary approval from a Human Research Ethics Committee. Details of the approval including the approval number and approving body must be provided in your manuscript and will be published if your manuscript is accepted. Note that approval is required even for the use of quantitative or qualitative results or feedback from formal unit and teaching reviews.*
- 4.** *The manuscript is not defamatory (and will not be defamatory, if published).*
- 5.** *The manuscript does not infringe (and will not infringe, if published) any other rights of a third party.*
- 6.** *You agree to indemnify the Western Australian Law Teacher's Review (WALTR), WALTR'S Editors, and any other person or entity connected to the publication of WALTR for any loss or damage arising from the breach of any of these warranties or for any other liability which may arise in connection with the publication of your manuscript.*
